

End User License Agreement

THIS LICENSE AGREEMENT (HEREINAFTER AGREEMENT) IS THE AGREEMENT BETWEEN YOU (THE PERSON OR COMPANY WHO IS BEING LICENSED TO USE THE SOFTWARE) AND CommerceLab (HEREINAFTER WE/US/OUR). THE AGREEMENT IS APPLICABLE TO ALL PRODUCTS/SOFTWARE/SCRIPTS/SERVICES YOU PURCHASE FROM US.

1. General Provisions

- (a) By using the Software you acknowledge that you have read this Agreement, and that you agree with the terms of the Agreement's content, and will use the Software in accordance with this Agreement only.
- (b) The Agreement comes into legal force as soon as you purchase the Software from our site or receive it through email or on some data medium at our discretion or by any other means.

2. Ownership

CommerceLab is the copyright holder of the Software. The Software or a portion of it is a copyrightable subject and is liable to law protection. Any activity that infringes the terms of this Agreement violates the copyright law and will be prosecuted according to the current law. We have the right to revoke the license of any user who is holding an invalid license.

3. License

This Agreement gives you the right to use the Software <u>on one domain only</u> for your personal or business use, subject to all other terms of this Agreement. Any distribution of the Software without our agreement, including noncommercial distribution is considered the violation of this Agreement and entails liability, according to the current law.

4. License Restrictions

- (a)You may not use any part of the Software code in whole or part in any other software or product or website.
- (b)You may not give, sell, distribute, sub-license, rent, lease or lend any portion of the Software to anyone. You are not allowed to place the Software on a server so that it is accessible via a public network such as the Internet for distribution purposes.
- (c)You must preserve the copyright information intact, this includes the text/link at bottom.
- (d)You may not remove «Developed by CommerceLab» link in the Software. In case you do so, you are obliged to compensate the commercial value of the Software as stated at the date you received the Software by any possible means. You are subjected to such money compensation within 30 (thirty) days after you are notified about the violation from Us or any of our representatives.

5. Limitation to Liability

(a)We will not be liable to you or any other third party for any indirect, special, incidental, or consequential damages caused to you, your information and your business arising out of the use or inability to use this Software.

(b)We are not liable to you or any other third party for prosecution arising from use of the Software against law or for any illegal use.

(c)If you fail to use the Software according with the terms and conditions of this EULA, it constitutes a breach of the agreement, and your license to use the program is revoked.

6. Downloads

All products are available for download once the payment has been accepted, verified and processed. If you can't download a product please check status of your payment via payment processor interface or contact our support operator.

7. Upgrades

We provide our customers with free upgrades of the purchased product, which are limited to the product version branch. It means that buying a product version N.x gives you the right to receive free updates for the version brunch N. (N.x, N.x.x). Once an update is available, you will be informed via e-mail and you can download it from "Downloadable products" area in your Account.

8. Amendments

We reserve the right to change this license agreement at any time and impose its clauses at any given time. This Agreement may only be modified by a writing signed by an authorized person of CommerceLab.

9. Termination

(a)License agreement remains effective until terminated. CommerceLab retains the right to terminate the license to use the Software at any time, if

in its sole discretion, you are not abiding by the terms of the Agreement, including, but not limited to, obscuring or removing any link or copyright notice as mentioned in this agreement. In this case you are bound to destroy all copies of the Software and all of its component parts.

- (b)You may terminate it at any time by destroying all copies of the Software. Termination of this Agreement does not bind us to return you the cost spent for purchase of the Software.
- (c) If you continue to use the Software after CommerceLab gives you notice of termination of your license, you hereby agree to accept an injunction to enjoin you from its further use and to pay all costs (including but not limited to reasonable attorney fees) to enforce our revocation of the license and any damages suffered by us because of your misuse of the Software.

10. Refund Policy

To ensure your protection we offer 25-day money back guarantee for ALL software products. (d) **Product was not delivered within 7 business days**. You didn't get the product within 7 days, either from the download page or directly via email within 7 business days.
