**Julie M. Desjardins** is a chartered accountant and an independent consultant in the area of performance measurement and reporting. She is an expert advisor, author and featured speaker on capital market disclosures including management's discussion and analysis, sustainability and climate change reporting. She is an active member of provincial, national and international committees on climate change.
