## <u>Transparency International Canada</u> <u>Sixteenth Annual General Meeting</u> Report of Senior Advisor on work of TI-Canada – 2012

In 2012, TI-Canada had a membership number of 114, with 5 Roundtable, 2 Charter, 2 Professional, 6 Voluntary Sector, 93 Individual and 6 Student Members. This number is similar to that of 2011, with a decrease of one Charter Member and two Individual Members and an increase of one Student Member.
